The complete text of the Minutes, Resolutions, and Policies are on file at the Stanton Community Schools Superintendent's Office and are available for public inspection during regular business hours. Availability of the agenda was communicated in an advertised notice and current copy of the agenda was maintained as stated in the notice. All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to the attendance of the public. Abbreviations: AMPVF- All members present voted for, MC- Motion carried.

A regular meeting of the Stanton Community Schools Board of Education was convened in open and public session on Monday, April 13, 2020 at 7:00 p.m. in the High/Middle School Library at the Stanton Community High School, 1007 Kingwood, Stanton, Nebraska and available through a teleconference. The meeting was called to order by President John Mandl.

Roll call was taken, and the following board members were present: Wendy Benson, Colleen Butterfield, Sarah Klinetobe, John Mandl, Shad Pohlman, and Tim Reese. Also present were Michael Sieh, Sarah Remm, and David Cunningham.

The Pledge of Allegiance was recited by all present. President John Mandl announced the location and informed the public of the current copy of the Open Meetings Act posted in the Library meeting room.

Motion was made by Wendy Benson, seconded by Shad Pohlman to declare the meeting open and properly published by advance notice in accordance with board policy #8342 with the agenda given to the president of the board and all members prior to the meeting date. AMPVF-MC.

Motion was made by Sarah Klinetobe, seconded by Tim Reese to approve the board agenda. AMPVF-MC.

Minutes from the March 9, 2020 regular board meeting, March 11, 2020 board retreat, and March 18, 2020 emergency meeting were approved and accepted by the Secretary.

A public forum was held.

Elementary Principal Sarah Remm reported delaying the offer of additional summer school employment contracts because of COVID-19 pandemic, on kindergarten round-up, and on preschool registration.

Secondary Principal David Cunningham presented a certified staff resignation for board acceptance; sought approval of a certified staff contract for 2020-2021 school year; and sought recognition of state qualifiers, medalists, and All-State students.

Superintendent Michael Sieh reported on the annual walk around of the buildings, grounds, and transportation; presented the Lower Elkhorn NRD Hazard Mitigation Resolution; requested approval of principal salaries and contracts; discussed the additional employment contracts for the upcoming school year; sought approval for a classroom furniture purchase; reviewed monthly financial transactions; gave a comprehensive annual review of the happenings of the Governance, Americanism

& Wellness committee; discussed authorizing and delegating to the Superintendent extra authority to respond to the COVID-19 pandemic; and discussed a resolution concerning student learning, graduation, and student advancement.

Motion was made by Sarah Klinetobe, seconded by Wendy Benson to approve the quote from School Specialty, in the amount of \$11,959.50, for classroom furniture. AMPVF-MC.

Motion was made by Tim Reese, seconded by Shad Pohlman to approve the Governance, Americanism & Wellness School Improvement Action Plan. AMPVF-MC.

Motion was made by Colleen Butterfield, seconded by Shad Pohlman to authorize and delegate to the Superintendent the authority to take any and all necessary actions, after consultation with the Board

President, to respond to the coronavirus epidemic and to continue district operations during a temporary shutdown. AMPVF-MC.

Motion was made by John Mandl, seconded by Colleen Butterfield to a) approve & authorize payment of District #3 bills presented at this meeting; b) accept the Activity Account Reports; c) accept the Treasurer's Report; d) accept the Account Summary Report; and e) accept the Revenue Report. AMPVF-MC.

The next regular monthly meeting will be May 11, 2020 at 7:00 p.m. in the High School /Middle School Library. The meeting was duly adjourned at 7:55 p.m.
