The complete text of the Minutes, Resolutions, and Policies are on file at the Stanton Community Schools Superintendent's Office and are available for public inspection during regular business hours. Availability of the agenda was communicated in an advertised notice and a current copy of the agenda was maintained as stated in the notice. All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to the attendance of the public. Abbreviations: AMPVF- All members present voted for, MC- Motion carried.

A regular meeting of the Stanton Community Schools Board of Education was convened in open and public session on Monday, July 13, 2020 at 7:00 p.m. in the High/Middle School Library at the Stanton Community High School, 1007 Kingwood, Stanton, Nebraska. The meeting was called to order by President John Mandl.

Roll call was taken, and the following board members were present: Sarah Klinetobe, Colleen Butterfield, Wendy Benson, John Mandl, Shad Pohlman and Tim Reese. Also present were Darren Soucie, David Cunningham, and Sarah Remm.

The Pledge of Allegiance was recited by all present. President John Mandl announced the location and informed the public of the current copy of the Open Meetings Act posted in the Library meeting room.

Motion was made by Wendy Benson, seconded by Sarah Klinetobe to declare the meeting open and properly published by advance notice in accordance with board policy #8342 with the agenda given to the president of the board and all members prior to the meeting date. AMPVF-MC.

Motion was made by Colleen Butterfield, seconded by Tim Reese to approve the board agenda. AMPVF-MC.

Minutes from the June 8, 2020 regular board meeting were approved and accepted by the Secretary.

A public forum was held.

Elementary Principal Sarah Remm reported the district has received the accreditation certificate for the 2020-2021 school year, presented the summer school teaching contracts, and reviewed the 2020-2021 elementary student handbook.

Secondary Principal David Cunningham reviewed the 2020-2021 1-1 Computer handbook, certified staff, non-certified staff, & secondary student handbooks; presented a quote for the 1-1 computers; presented a new preschool paraprofessional; reviewed the 2020-2021 coaching assignments; presented contracts for non-teaching coaching & volunteer coaching; and discussed graduation.

Superintendent Darren Soucie briefed the board on summer projects; reviewed the monthly bills; presented several board policies for first reading; recommended the 2020-2021 hot lunch prices; reviewed the student fees, parental/community involvement in schools, anti-bullying and option enrollment policies; recommended the 2020-2021 substitute pay; reported on the former superintendent's 2019-2020 absences; and requested input on the date of the new superintendent transition special meeting.

Motion was made by Shad Pohlman, seconded by Colleen Butterfield, to approve the Additional Employment Contract, for Summer School, between the school district and the following teachers: Janelle Peter, Sharon Schroeder, and Shellie Sieh. AMPVF-MC.

Motion was made by Sarah Klinetobe, seconded by Wendy Benson to approve the Elementary Student Handbook; Secondary Student Handbook; Certified Staff Handbook; Classified Staff Handbook; and 1-1 Student Handbook for the 2020-2021 school year. AMPVF-MC.

Motion was made by Colleen Butterfield, seconded by Tim Reese to accept the bid from PrecisionIT for student computers in the amount of \$37,706.90. AMPVF-MC.

Motion was made by Wendy Benson, seconded by Sarah Klinetobe to approve employment of Tammy Glaser as a preschool paraprofessional at \$12.37/hour. AMPVF-MC.

Motion was made by Wendy Benson, seconded by Colleen Butterfield to approve the following contracts between the school district and Sonja Locke-Head Volleyball, Grant Clark-Assistant Volleyball, Randy Hansen-Head Wrestling, Susan Seeman-Assistant Drama, Cory Locke & Shaun Vogel-Head Boys Golf, Matthew Alexander-Assistant JH Boys Basketball & Assistant JH Track, Adam Dover-Assistant Football, Kenny Wurdinger-Assistant Wrestling, Robbie Johnson-Head JH Wrestling, and Robert Chilcoat, Jr.-Assistant JH Volleyball for the 2020-2021 school year. AMPVF-MC.

Motion was made by Sarah Klinetobe, seconded by Shad Pohlman to approve the following volunteer coaching contracts between the school district and David Morfeld-Assistant Girls Basketball, Melanie Mann-Assistant Drama, and Robbie Johnson-Assistant Wrestling for the 2020-2021 school year. AMPVF-MC.

Motion was made Tim Reese, seconded by Colleen Butterfield to approve the first reading of board policies #1040, 1500, 1501, 5101, 5103, 5406, 5506, 6111 & 6117. AMPVF-MC.

Motion was made by Sarah Klinetobe, seconded by Wendy Benson, to set lunch prices as follows for the 2020-2021 school year: lunch-students K-6: \$2.75, students 7-12: \$2.85 & adults: \$3.70; breakfast-students K-12: \$1.85 & adults: \$2.30; beverages-milk: \$0.60 & juice: \$0.60; Main Ala carte: \$1.40. AMPVF-MC.

Student Fees Policy #5416:

- The administration presented a review of the amount of money collected from students pursuant to, and the use of waivers provided in, the student fee policies of the District for the 2019-2020 school year.
- A public hearing was held to discuss, consider, and receive input on a proposed Student Fees Policy. The public was given the opportunity to present information and opinions on the proposed Student Fees Policy.
- Motion was made by Sarah Klinetobe and seconded by Tim Reese that the Student Fees Policy #5416 for the 2020-2021 school year, inclusive of Appendix "1," be adopted. AMPVF-MC.

Parental Involvement Policy #6400:

- A public hearing was held to discuss, consider, and receive input on the Parental Involvement Policy. The public was given the opportunity to present information and opinions on the Parental Involvement Policy.
- Motion was made by Colleen Butterfield and seconded by Wendy Benson, that the Board's current Parental Involvement Policy #6400 be re-adopted without alteration. AMPVF-MC.

Bullying Policy #5415:

- A Bullying Policy was presented to and reviewed by the Board.
- Motion was made by Tim Reese and seconded by Shad Pohlman, that the Board's current Bullying Policy #5415 be re-adopted without alteration. AMPVF-MC.

Motion was made by Shad Pohlman, seconded by Wendy Benson to accept the resolution that establishes option enrollment capacities for the 2020-2021 school year. AMPVF-MC.

Motion was made by Sarah Klinetobe, seconded by Colleen Butterfield to accept Administrative Regulation #4133R1, Substitute Salary Schedule for the 2020-2021 school year. AMPVF-MC.

Motion was made by Wendy Benson, seconded by Tim Reese to a) approve & authorize payment for District #3 bills presented at this meeting; b) accept the Activity Account Report; c) accept the Treasurer's Report; d) accept the Account Summary Report; and e) accept the of Revenue Report. AMPVF-MC.

The next regular monthly meeting will be August 10, 2020 at 7:00 p.m. in the High School /Middle School Library.

The meeting was duly adjourned at 8:00 p.m.
