The complete text of the Minutes, Resolutions, and Policies are on file at the Stanton Community Schools Superintendent's Office and are available for public inspection during regular business hours. Availability of the agenda was communicated in an advertised notice and current copy of the agenda was maintained as stated in the notice. All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to the attendance of the public. Abbreviations: AMPVF- All members present voted for, MC- Motion carried.

A regular meeting of the Stanton Community Schools Board of Education was convened in open and public session on Monday, September 14, 2020 at 7:00 p.m. in the High/Middle School Library at the Stanton Community High School, 1007 Kingwood, Stanton, Nebraska. The meeting was called to order by President John Mandl.

Roll call was taken, and the following board members were present: Tim Reese, Colleen Butterfield, Wendy Benson, Sarah Klinetobe, John Mandl, and Shad Pohlman. Also present were Darren Soucie, Sarah Remm, and David Cunningham.

The Pledge of Allegiance was recited by all present. President John Mandl announced the location and informed the public of the current copy of the Open Meetings Act posted in the Library meeting room.

Motion was made by Colleen Butterfield, seconded by Tim Reese to declare the meeting open and properly posted and/or published by advance notice in accordance with board policy #8342 with the agenda given to the president of the board and all members prior to the meeting date. AMPVF-MC.

Motion was made by Sarah Klinetobe, seconded by Wendy Benson to approve the board agenda. AMPVF-MC.

Minutes from the August 10, 2020 regular board meeting were approved and accepted by the Secretary. A public forum was held.

Elementary Principal Sarah Remm presented the annual multicultural report, reported on the MTSS updates, informed the board on Acadience reading program and fall assessments, reported on the PreK-6 enrollment figures, explained how special education is responding to COVID, and gave other COVID response updates.

Secondary Principal David Cunningham presented an assistant volleyball coach resignation and sought approval of a non-teaching coaching contract for board acceptance, sought approval for a classified staff contract for board approval, explained homecoming activities, discussed Live Streaming Services, reported on 7-12 enrollment figures, and informed the board of the meeting with the county attorney about attendance policy #5008.

Superintendent, Darren Soucie, and Head of Operations, Russ Johnson, presented the annual Buildings, Grounds & Transportation comprehension report to the board and discussed purchases, including a new bus.

Superintendent Darren Soucie provided a summarized report on the summer lunch program, announced the summer lunch program was extended, discussed the 2020-2021 budget and tax request fund levies, reviewed monthly bills, requested approval for Sparq Meetings, and informed the board of upcoming conferences.

Motion was made by Sarah Klinetobe, seconded by Tim Reese to approve the annual multicultural report. AMPVF-MC.

Motion was made by Shad Pohlman, seconded by Wendy Benson to accept the resignation of Grant Clark with regrets. AMPVF-MC.

Motion was made by Colleen Butterfield, seconded by Sarah Klinetobe to approve the Assistant Volleyball contract between the school district and Rachel Kaup for the 2020-2021 school year. AMPVF-MC.

Motion was made by Tim Reese, seconded by Wendy Benson to approve the contract between Lee Renn and the school district for the position of Temporary Custodial/Maintenance for the 2020-2021 school year with pay of \$13.82 per hour.

Attendance Policy #5008 was presented to and reviewed by the Board. Motion was made by Colleen Butterfield, seconded by Sarah Klinetobe that the Board's current Attendance Policy (#5008) be re-adopted without alteration. AMPVF-MC.

Motion was made by Wendy Benson, seconded by Tim Reese to accept the bus bid from Cornhusker International in the amount of \$87,550.00. AMPVF-MC.

Motion was made by Shad Pohlman, seconded by Colleen Butterfield to approve the resolution of the adoption of the 2020-2021 budget. AMPVF-MC.

Motion was made by Colleen Butterfield, seconded by Shad Pohlman to approve the 2020-2021 property tax request resolution for Stanton County School District #3. AMPVF-MC.

Motion was made by Sarah Klinetobe, seconded by Colleen Butterfield to approve the purchase of Sparq Meetings software for \$2600.00. AMPVF-MC.

Motion was made by Time Reese, seconded by John Mandl to a) approve & authorize payment for District #3 bills presented at this meeting; b) accept the Activity Account Reports; c) accept the Treasurer's Report; d) accept the Account Summary Report; and e) accept the Revenue Report. AMPVF-MC.

The next regular monthly meeting will be October 12, 2020 at 7:00 p.m. in the High School /Middle School Library.

The meeting was duly adjourned at 8:27 p.m.
